

Relatively marginalized and unattributed Black occultist and yoga instructor, originally from Guyana (Caribbean) and England. "Rollo Ahmed was a Guyanan national, born Abdul Said Ahmed c. 1898. He emigrated to England in the inter-war period, initially to work as a theatrical performer



and latterly
as a
herbalist,
Yoga
teacher,
author,
lecturer and
occultist.
Like other
Black
immigrants,
Ahmed's
attempts to

gain conventional employment were thwarted due to the widespread racism of the period. As a result, he played on his 'exoticism' in England as a self*promotional tool – for example, claiming to have* been born in Egypt so as to enhance his reputation as a purveyor of esoteric wisdom. He was a familiar face on the 1930s Bohemian literary scene, counting Dennis Wheatley and Aleister Crowley amongst his friends, but struggled to provide a comfortable living for himself and his family, compelling him, on occasion, to seek dubious forms of income. Ahmed was the author of two books - The Black Art (1936), a history of occultism and magic, and I Rise: The Life Story of a Negro (1937), an eloquent semiautobiographical novel that moves from Guyana to Liverpool to London, vividly portraying the struggles of a Black man in the 'mother country.'" Josiffe, Christopher (2014) British Voodoo: the Black art of Rollo Ahmed. Fortean Times (316-7). Originally published in 1936, the Black Art is a comprehensive, biographical, and self-reflective history of black magic. Ahmed spends time re-telling the history of magic, the application and investigation of magic from a multi-cultural perspective. He also gives a dire warning about the glamour and lure of practicing black magic, calling it 'fatalistic' and 'empty.' However, he was more apt than Wheatley to author a book on this topic (said by Wheatley), as he was privy to ethnographic exposure having lived in the West Indies and other 'non-Westernized' countries. His views are his own, and the description perform as a narrative rather than scholarly investigation. Supposedly, Ahmed's life experiences were character sketches for many of Wheatley horror novels. Overall, a silenced voice in occult history, often underrecognized and shadowed during the time of early 20th century Occult Revival.

Eliza Butler, or Elsie (1885-1959) as she was more generally known, was born in Bardsea, Lancashire, into an old Irish family. 

More than just an account of the history of Rosicrucianism in the United States, this inventive sketch illustrates the life of Pascal Beverly Randolph, one of the most prominent

African American occultists, healers, and seers, as well as 19th century authors. However, claimed to be unattributed and false by many historians.

Reuben Swinburne Clymer (November 25, 1878 -June 3, 1966) was an American occultist and modern Rosicrucian Grand Supreme Master of the FRC (Fraternitas Rosae Crucis), perhaps the oldest continuing Rosicrucian organization in the Americas. He practiced alternative medicine, and wrote and published works on it as well as (his version of) the teachings of Paschal Beverly Randolph (1825-1875), alchemy, nutrition, religion, sex magic and spiritualism. In either 1900 or 1904, Clymer got into publishing with his Philosophical Publishing Company, which he used to keep Paschal Beverly Randolph's books in print well into the 20th century. Clymer was deeply influenced by Randolph, of whom he created a hagiographic story of Randolph, using correspondence, court litigation transcriptions and mentions in surrounding press and other correspondence (i.e. Annie Besant). Regardless of the "accuracy" of Clymer's narratives and primary source citations, Randolph's life is so marginalized by occult scholarship, it isn't until Deveney's biography and the work of the Joscelyn Godwin do we have much reference to the research and writings of an important Black American figure so intrinsic with occult teachings and alternative medicine. This sketch provides an exaltation of PBR, but also challenges the contemporary overrated influence of Aleister Crowley. Scarce and not represented in many US library holdings. A popular guide to invocation and the practice of black magic. It clearly draws from a number of sources including Barrett's "The Magus," the "Goetia." According to the copyright page the book was first published in 1936, and this edition by Dorene Publishing Co. is copyright 1940. The paper type, binding, etc. would suggest that it probably dates from then (1940), not unlike many of the 'pulp magic' books produced at this time.

"John Dewey first joined the Church of Satan in 1970 and is today an Adept in the Temple of Set. Also known by his magickal name of The Daimon Egan, he is editor of Brimstone Quarterly, journal of the Ancient

Brotherhood of Satan (ABOS). The purpose of ABOS is described as being to "change consciousness by known ignominious methods", "to restore Satan's proud legacy and to resurrect His traditional role as 'The Adversary'. To unleash all the Powers of Hell. Igniting chaos to achieve freedom from tyranny." ABOS follows the tradition of the early German order, the Fraternitas Saturni. Their philosophy is described as 'Nietzschean Thelemism.'" Includes correspondence, news, and much coverage of the conflicts between the Temple of Set and Anton LaVey's Church of Satan. The fourth issue, largely taken up with a critique of LaVey, includes an interesting passage on the relationship to the Situationists and Satanism. Also includes a letter to the editor from Ian Read from Chaos International, Sol Invictus fame and features of the art of Jeff Gaither, artist for the Misfits, Guns N' Roses, Van Halen, Insane Clown Posse, and GG Allin, including over 400 album covers. Scarce copies, did continue into a second volume.

Earl Galvin (1946-1998) based in San Francisco, was an early part of the Gay Liberation Front (1969-1971), the first radical direct action group that emerged in New York after the legendary Stonewall Riots. His papers are at the GLBT Historical Society. It appears Galvin was studying astrology and Eastern philosophy in the years post-Stonewall.

Many of the worksheets in the collection were generated from the Church of Light based in Los Angeles. The Church of Light was incorporated November 2, 1932 in Los Angeles, California. Its mission is "to teach, practice, and disseminate The Religion of The Stars, a way of life for the Aquarian Age, as set forth in writings of C.C. Zain." The 1932 reorganization as The Church of Light was a response to ordinances passed that year by Los Angeles County "prohibiting both the teaching and practice of astrology." The typescript journal included is from the Church of Light based in Wichita, Kansas, Vol. 1, Number IV, 1938. It features articles, lesson reviews, and worksheets, one image of members from Kansas and also features an image of members in Accra, Gold Coast, West Coast Africa. The collection also includes materials from the astrological faculty based in San Francisco, from the director Doris Chase Doane.

"A noted astrologer, Doane was born April 4, 1913, at Mansfield, Massachusetts. After high school she left New England for California to attend the University of California, Los Angeles, from which she received her B.S. in psychology in 1944. She had previously become interested in astrology and associated herself with Elbert Benjamine (C.C. Zain) and the Church of Light. She taught astrology while going through the complete Church of Light curriculum, which she completed the same year as her work at UCLA. Besides her works in astrology, Doane gave a considerable amount of time to changing laws that prevented astrologers from operating in some states and cites by equating

astrology with fortune-telling. In that endeavor she became a strong advocate for training, professionalism, and certification of astrologers. She was elected president of the American Federation of Astrologers in 1979."



Svartkonstböcker is a fully revised edition of Dr Johnson's 2010 PhD thesis, "Tidebast och Vändelrot: Magical Representations in the Swedish Black Art Book Tradition," featuring a thorough, path-

breaking study of the black art book tradition in Sweden, as well as English translations of 35 Swedish black art books ranging from the 1690s to the 1940s, including over 1900 spells and a robust index.


The late Dr. Johnson always wished that his work would see print publication in its entirety. Other publishers have

offered to produce this work in two volumes, prioritizing the spells in the black art books over the scholarly apparatus

that contextualizes them. Here Revelore Press presents the work in full, comprising over 650 pages of material. Minor errors from the PhD manuscript have been rectified, and archival images of the characters, sigils, and illustrations have been restored in high fidelity. This is the definitive source work for the Swedish magical corpus of black art books.



A matching reprint set of these English language translations of two of the major early guides used by church and legal authorities to define and detect witchcraft and oversee its prosecution and punishment. The Compendium Maleficarum, compiled by the Ambrosian Friar Maria Guazzo, was printed in the Ambrosian College print shop in Milan (the first edition in 1608). This key work on demonology and witchcraft builds upon the already familiar content of its 15th and 16th century predecessors like Heinrich Kramer's Malleus Maleficarum (1487) and Nicholas Rémy's Daemonolatreiae libri tres (1595) with the inclusion of specifically placed and striking woodblock illustrations in the text. These cuts are repeated occasionally through the three books, which are formatted as a series of "Doctrina" and "Exempla", exploring the lore of European witchcraft practices with liberal references and examples from Kramer, Rémy and many others, both contemporary and from antiquity, often exploring supernatural causes to medical maladies. There is an extensive index of these citations. The sensational illustrations depict well dressed men and women in congress with various incarnations of a winged and tailed Devil, trampling the cross, giving to the Devil pieces of their clothing, striking their name from the book of life and inscribing it in the book of death. They also show women flying to the Sabbat on the back of a goat, the gathering of human remains for use in magical concoctions via exhumation or removal from the gallows, the consumption of a Sabbatic feasts, served and attended by non-human beings, a witch kissing the Devil's buttocks, and a depiction of a witch disguised as a wolf - Jane P. Davidson cites this as the only example of a 17th century witchcraft text to contain images of lycanthropy. The text was compiled at the request of Cardinal Federico Borromo, the Archbishop of Milan, perhaps prompted by Guazzo's performance of an exorcism in 1605 on the Duke Johan Wilhelm of Cleves. It was

first translated into English in 1929 by Montague Summers.

An important late sixteenth century text on witchcraft "drawn from the capital trials of 900 persons, more or less, who within the last fifteen years have in Lorraine paid the penalty of death for the crime of witchcraft" by Nicholas Remy, 'Privy Councillor to the Most Serene Duke of Lorraine, and Public Advocate to his Duchy.' In 1591 he became the Attorney General of Lorraine," in which position he was able to influence and override local magistrates too lenient with witches, keeping up his hatred of witches to the last. Remy's claims as an expert were emphasized by the title page wherein he boasted he had condemned 900 witches in fifteen years. Remy to some extant replaced the Malleus Maleficarum as the final authority on witch hunting," [Robbins.] From the introduction and includes new additional notes by leading occult and witchcraft author and scholar, Montague Summers: "No historical record could be more valuable, no record could be more interesting than this graphic account compiled from first-hand knowledge..." The "Kybalion" Hermetic Philosophy, originally published by the Yogi Publication Society in 1908 by a person or persons under the pseudonym of "The Three Initiates", is a book claiming to be the essence of the teachings of Hermes Trismegistus. Its philosophies, in conjunction with others, have become founding pillars within the New Thought movement of the early 1910s. The book early on makes the claim that it makes its appearance in one's life when the time is appropriate and includes axioms and insights similar to those found in the Book of Proverbs. The most common proposal is that The Kybalion was authored by William Walker Atkinson, either alone or with others, such as Paul Foster Case and Elias Gewurz.
